Team captains/leaders must submit a roster containing the participant's name, temple name and number. The roster must be submitted to and received by the office of Imperial Director of Student Aid no later than July 1, 2022

All members of the team must be registered participants at the Imperial Council Session.

ONLY registered teams (members) entered in the contest, will participate in the inspection, riding competition and the award ceremony.

All team captains/leaders must participate in the pre-competition meeting, scheduled by the Imperial Director Student Aid Dept. or his designee, to receive instructions, to determine the order of inspection and performance appearance.
