# ARTICLE 1: NAME OR TITLE OF LEGION OF HONOR CLUB

# ARTICLE 2: P<mark>URPOSE</mark>

- 1. To advance the cause of Shrinedom in the Oasis, Desert and Domain
- 2. To advance the cause of our youth education through the Roscoe C. Washington Scholarship Program.

# ARTICLE 3<mark>: OBJECTIVES</mark>

- 1. To promote programs and activities for the betterment of Prince Hall Shrinedom that are in Harmony with the Imperial Council and Temples.
- 2. To unite fellow Nobles in a bond of fraternal brotherhood.
- 3. To create an environment for the interchange of ideas and distribution of information relating to Shrine issues and the growth in Shrine membership.
- 4. To provide incentive and strength to their respective temples physically, morally, and financially.
- 5. To work diligently in the Imperial Legion of Honor program.

# **ARTICLE 4: MEMBERSHIP**

1. Limited to recipients of the Imperial Legion of Honor award as Officially documented. Participation in the club is strictly voluntary, however a Noble awarded the LOH cannot be denied membership. The Potentate by virtue of his office can attend the LOH meetings weather he is a legionare or not based on position.

#### **ARTICLE 5: OFFICERS**

- 1. There shall be three (3) principle officers in the Temple Legion of Honor Club. The members of the Club shall elect them annually.
  - a. President
  - b. Vice-President
  - c. Secretary/Treasurer

#### **ARTICLE 6: MEETINGS**

1. Meetings shall be at the discretion of Temple Legion of Honor Club membership. A monthly meeting is suggested; however any meeting should be scheduled that will encourage full participation. These said meetings should not be contrary to the Temple and/or Imperial Council By-Laws.

#### ARTICLE 7: DUES AND FEES

 There shall be no mandatory annual club dues structured in LOH clubs. However, voluntary contributions for administration cost or donations to the LOH Scholarship Fund program costs shall be permissible, not to exceed \$20.00 per member. Other voluntary donations are permissible. Strict records of accountability shall be maintained and available on call for audit by the Illustrious Potentate or the Imperial Director.

#### ARTICLE 8: REPORTS

- 1. Semi-Annual progress and activity reports shall be sent to the Imperial Director of the Legion of Honor. The Imperial Deputy Director of the LOH or Regional Area Captain as requested/required will furnish these forms to the President of the Club.
- 2. The Imperial Director of the LOH will report in summary to the Imperial Potentate.
