Deserts and Temples throughout the Domain should be in the process of recording and tracking all completed and planned charitable work for the period of July 1, 2024 through June 30, 2025. The Temple/Desert Charity Report form can be downloaded from the Imperial Council Website (<a href="https://aeaonms.org/recorder-and-treasurer/">https://aeaonms.org/recorder-and-treasurer/</a>). In years past, we have utilized both the electronic method of submission as well as the option to mail reports to the Headquarters. For the 2024-2025 reports, **electronic** submission will be the **only** option utilized for your Temple/Desert to receive credit towards end of year rewards.

Once you locate the **Temple Charitable Donation Report Form** on the website, save the form to your computer, complete the report in its entirety and submit it via email. When submitting the form electronically, your name and email address will be accepted in lieu of the signatures and seal. Electronic submissions should **only** be submitted by either the Illustrious Potentate or Temple Recorder. The appointed Temple Charity representative should submit the report directly to one of the two officers **monthly.** For Deserts, please have the report submitted by the Deputy of the Desert or the Desert Recorder. Please submit all reports to templereports@aeaonms.org. In the subject line of your email, please put Temple Name and Number (Desert Name), Month Report (i.e. ABC Temple No. 123 Jan 2025 Report or Desert of ABC Jan 2025 Report).

It is highly recommended that each Temple assigns a Charity Representative that can properly track the hours, events and time submitted. We would like to be able to accurately keep track of
